"In reality, nobody – including the courts – cares whether a spouse has cheated unless it directly affects legal issues within the divorce," says Igers Vangjeli, Managing Attorney at Kansas Legal Group. "Yet, while criminal charges are virtually unheard of, adultery can still play a role in divorce proceedings – not because of the statute itself, but due to the financial and emotional fallout that often follows infidelity."

When Infidelity Becomes a Factor in Divorce

Kansas courts prioritize financial and parental concerns over personal conduct in divorce cases. However, Kansas Legal Group notes that adultery can play a role in specific legal disputes, including:
